**GRANT TERMS AND CONDITIONS FORM**

The National Railroad Construction and Maintenance Association is (“NRC”) is awarding this grant to (“Grantee”) contingent upon the following:

**EDUCATIONAL INSTITUTION STATUS & NRC USE OF INFORMATION IN APPLICATION**

Any College, University or Technical School with a program supporting the railroad industry, rail engineering, construction management or other related programs.

**EXPENDITURE OF FUNDS**

This grant is made for the purpose outlined in the grant award letter and may not be expended for any other purpose without The NRC's prior written approval. The NRC Education Grant funds are intended for targeted student educational and research purposes and are not to be used for administrative, general fund or institution or program overhead costs. The Grantee must provide an interim and final progress report to the NRC on how the grant funding is being used. You may not expend any grant funds for any political or lobbying activity or for any purpose other than one specified in Title 26 Section 170(c) (2)(b) of the U.S. Code. The NRC Education Grant shall be expended within 12 months of the date of the grant award letter. Any portion of the grant that is not expended within the required time period shall be returned immediately to the NRC. Any awarded amount is only for that 12 month period. Any current awardee institution will need to reapply to the following year's NRC Education Grant program if they are interested in potential funds for that calendar year.

**NO ASSIGNMENT OR DELEGATION**

You may not assign, or otherwise transfer, your rights or delegate any of your obligations under this grant without prior written approval from the NRC.

**RIGHT TO MODIFY OR REVOKE**

The NRC reserves the right to discontinue, modify or withhold any payments to be made under this grant award or to require a total or partial refund of any grant funds if, in the NRC's sole discretion, such action is necessary: (1) because you have not fully complied with the terms and conditions of this grant; (2) to protect the purpose and objectives of the grant or any other charitable activities of the NRC; or (3) to comply with the requirements of any law or regulation applicable to you, the NRC, or this grant.
